(5) Procedure for issuance of tickets/return of tickets etc.

However the balance payment of 75% of face value of tickets sold subject to minimum specified limit as on the date of draw, if any, has to be paid on or before the date of draw i.e. 19.11.2012 itself through Demand Draft failing which the agent shall be charged interest @18% p.a, for the delayed period.
